### OPTION TO PURCHASE

### RIGHT TO POSSESSION/TITLE

Music World retains the title and right of possession for all rental instruments for the entire period of the rental term. Said property may not be sold, mortgaged, pawned, defaced or disposed of by renter while bound by the terms of this Rental Agreement.

### EXCHANGES

The instrument covered by this Rental Agreement may be exchanged for any other instrument during the rental term, based upon renter's account being current. When applicable, any difference in price categories between instruments will be reflected in Rental Agreement as of the date of exchange.

### LOSS, DAMAGE COVERAGE

Coverage includes all adjustments and repairs plus loss due to fire or theft or accidental damage with no deductible subject to the following terms:

- An instrument that is totally destroyed by accidental damage or fire (or theft) provided a police report is filed within 24 hours of the discovery of the theft) will be replaced by an instrument of comparable value.
- Cosmetic appearance such as scratches, minor dents and finish is normal wear and tear.
- Malicious damage is not covered.
- Accessories, including but not limited to mouthpieces, straps, reeds, oils, and drum sticks, are not covered.
- All repairs must be made by Music World to be covered by this policy. Attempts to repair instrument yourself or take the instrument to an outside source will void the coverage.
- Your account must be current in order to make a claim.

### OPTIONAL LOSS, DAMAGE COVERAGE

- Yes, I would like the loss, damage coverage at \$5.00 per month per instrument for group I, \$6.00 per month for group II or \$7.00 per month for group III.
- No, I do not want the loss, damage coverage. I understand I am assuming financial responsibility for all damage or loss (normal wear and tear expected) and will maintain the instrument in its condition at time of rental.

### TERM OF RENTAL

Rental agreement begins upon acquisition of instrument with minimum of one month rental. Based upon renter's compliance of conditions outlined in this agreement, renter may use rental instrument for successive one month terms automatically renewable each month. All rental fees are nonrefundable. A late fee of \$10.00 will be applied to all payments received 15 days or more after the due date.

### LOSS AND DAMAGE

Renter is responsible for the maintenance and servicing, as well as any loss, damage or destruction of instrument covered by this Rental Agreement (beyond normal wear and tear.) Renter is also responsible for alerting Music World at once regarding problems with rental instrument. Renter may elect to purchase loss and damage coverage by enrolling in our Loss and Damage Program.

### CONTRACT TERMINATION/CUSTOMER

Should renter wish to terminate Rental Agreement, renter is responsible for returning said instrument to Music World in the same condition as when it was rented (normal wear and tear expected). Renter must pay all accrued rental fees in full at the time of instrument return. Rental fees are nonrefundable and apply only toward rental of said instrument. Do not leave the instrument in school if you wish to cancel this agreement. You remain liable under this agreement unless you have received a return receipt from us. Your school is not a party to this transaction, regardless of what location you rented the instrument.

### CONTRACT TERMINATION/MUSIC WORLD

Should renter fail to make rental payments or breach the conditions of Rental Contract in any way, Music World reserves the right to demand return of said instrument via certified mail sent to the address provided on the contract or subsequent written notice of change. Failure to comply with such notice within 5 business days will subject the renter to civil and/or criminal penalties. Renter is responsible for any outstanding rental or damage charges. If instrument is not returned, renter is responsible to pay net value of comparable new instrument.

### CHANGE OF ADDRESS

Renter is responsible for alerting Music World within 10 days of any changes in billing address, phone number, credit card, debit card or school attendance.
